## Summary

This policy is to establish consistency and improve the processes through which the Resort Village of Candle Lake manages the Candle Lake Cemetery

### Policy

#### **GENERAL RULES:**

- A copy of the cremation or death certificate must be provided to the Resort Village of Candle Lake office prior to burial.
- Scattering of ashes in the Resort Village of Candle Lake Cemetery is strictly prohibited.
- Two (2) traditional caskets per plot or one (1) traditional caskets and two (2) cremations allowed per plot.
- A maximum of four (4) cremations are permitted per plot.
- Headstones must be installed at the top of a grave
- Prohibited surface grave covers, fences, curbing or landscaping materials of any sort, planting of trees, shrubs, plastic flowers or greenery (other than grass)
- The Resort Village of Candle Lake shall have the authority to remove all floral designs, flowers, trees, shrubs, plants or herbage of any kind from the cemetery as soon as, in the judgment of the Resort Village of Candle Lake, they become unsightly, dangerous or detrimental to the cemetery.
- Solar lights and ornaments are not permitted on graves.

#### PLOTS:

Plot size is 5 ft  $\times$  10 ft.

### **MONUMENTS:**

• All grave markers/headstones within the Resort Village of Candle Lake shall have concrete or granite foundations installed flush with ground level. The foundation must not exceed 42 inches in width, 18 inches in length and must have a minimum depth of 3 inches.

### FEES:

• As set out in Schedule "A" to this policy.
