Bylaw No. 14-2024

A bylaw to provide for the SALE of dedicated lands pursuant to Section 199 of The Planning and Development Act, 2007.

The Council of the Resort Village of Candle Lake in the Province of Saskatchewan, enacts as follows:

1. To sell the following dedicated land at \$5.00 per square foot:

Part of Block R6 Plan 72PA06478 Ext.0

with the sale proceeds to be deposited to the dedicated lands account for future expenditure on other dedicated lands.

2. That this Bylaw take effect upon the date it is approved by the Minister of Government Relations.


INTRODUCED AND READ a first time this 25th day of April 2024.

READ A THIRD TIME AND ADOPTED this 23rd day of May 2024.

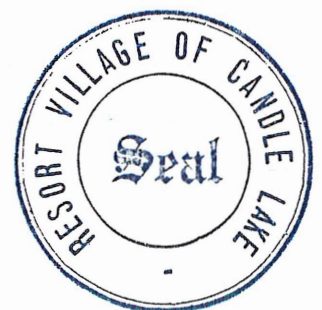
