

# BYLAW 7/2018

## OF THE RESORT VILLAGE OF CANDLE LAKE IN THE PROVINCE OF SASKATCHEWAN

### A Bylaw of the Resort Village of Candle Lake to amend Bylaw 03/2016 known as the Zoning Bylaw.

The Council of the Resort Village of Candle Lake in the Province of Saskatchewan hereby enacts as follows:

1. The Zoning Bylaw, Bylaw No. 03/2016 be amended as follows:
  - A. The **"TABLE OF CONTENTS"** be amended as follows:
    - a. Removing Heading "15. CON – CONSERVATION DISTRICT" AND REPLACING WITH NEW Heading "15. RC – RESOURCE CONSERVATION DISTRICT"; and
    - b. Removing Heading "16. RE-RESORT EXPANSION DISTRICT" and sub headings "16.1 Permitted Uses, 16.2 Discretionary Uses, and 16.3 Regulations".
  - B. Section **"4 ZONING DISTRICTS AND ZONING DISTRICT MAP, sub-section 4.1 Zoning District Interpretation, Clause 1"** be amended as follows:
    - a. by removing from the Table the District "Conservation" and related Symbol "CON" and replacing with new District "Resource Conservation" and related Symbol "RC"; and
    - b. by removing the District "Resort Expansion" and reference symbol "RE".
  - C. Section **"5 GENERAL REGULATIONS, sub-section 5.5 Accessory Buildings, Uses and Structures, Clause 3"** be amended by removing from the Table, Column 1, the Zone (District) symbols "CON RE" and replacing with the symbol "RC".
  - D. Section **"5 GENERAL REGULATIONS, sub-section 5.11 Signage, Clause 4"** be amended by removing the words "In the Conservation District" with the words "In the Resource Conservation District".
  - E. The Section following Section 14 titled **"14 CON- CONSERVATION DISTRICT"** be amended as follows:
    - a. By removing the Heading **"14. CON-CONSERVATION DISTRICT"** and replacing it with the new Heading **"15. RC- RESOURCE CONSERVATION DISTRICT"**; and
    - b. By removing from sub-section 15.1 Permitted Uses, Clause 1. the Symbol "CON" and replacing with the Symbol "RC"; and
    - c. By removing from sub-section 15.2 Discretionary Uses, Clause 1. the Symbol "CON" and replacing with the Symbol "RC"; and
    - d. By removing from subsection 15.3 Regulations, Clause 1" the symbol "CON" and replacing with the Symbol "RC".

- F. By removing in its entirety, the Section immediately following the Section referenced in E.a. above "RE – RESORT EXPANSION DISTRICT" and all sub-sections "16.1 Permitted Uses, 16.2 Discretionary Uses, and 16.3 Regulations".
- G. **"APPENDIX A – ZONING DISTRICT MAP, Overview Map, and Sheets 1-16 inclusive"** be amended as follows:
  - a. By removing from the Table entitled "ZONING DISTRICTS" on all the maps the Symbol and Zoning Districts entitled "CON CONSERVATION" and "RE RESORT EXPANSION"; and
  - b. By inserting in the Table "ZONING DISTRICTS" as referenced in G.a. above the new Symbol and related Zoning District "RC RESOURCE CONSERVATION".
- H. **"APPENDIX A – ZONING DISTRICT MAP, Overview Map, and Sheets 1-16 inclusive"** be further amended by removing from all maps the Symbols "CON" and "RE" where they appear and replacing with the Symbol "RC".

2. This Bylaw shall come into force and take effect upon the approval by the Minister.
