

BYLAW NO. 09 of 2018

**OF THE RESORT VILLAGE OF CANDLE LAKE
IN THE PROVINCE OF SASKATCHEWAN**

**A Bylaw of the Resort Village of Candle Lake to amend the
DISTRICT OFFICIAL COMMUNITY PLAN for the
North Central Lakelands Planning District**

Whereas, the member Municipalities of the North Central Lakelands Planning District wish to amend the *District Official Community Plan (DOCP)*, for the purpose of revising Policies within the Candle Lake Region.

And Whereas, the Council of the Resort Village of Candle Lake enacted the *DOCP* by Bylaw No. 12 of 2013;

Therefore, the Council of The Resort Village of Candle Lake, in the Province of Saskatchewan, in open meeting assembled, hereby enacts as follows:

1. This Bylaw may be cited as "The DOCP Candle Lake Conservation Lands Amendment Bylaw";
2. The North Central Lakelands Planning District DOCP, being Schedule 'A' to Bylaw No. 12 of 2013, is hereby amended as follows:

PART E-2, Section 22 – Candle Lake Region, Sub-section 22.2 Policies is amended as follows:

- a. By deleting the existing clause (3) and replacing it with the following:
“(3) Generally, unless already zoned for development purposes, all undeveloped land will be zoned Resource Conservation District.”
 - b. By deleting the existing clause (4) and replacing it with the following:
“(4) Notwithstanding the immediately preceding Clause (3), Council will consider requests for re-zoning for development purposes of undeveloped private land based on the policies as contained in this OCP.”
3. This bylaw shall become effective on the date of approval of the Minister of Government Relations.

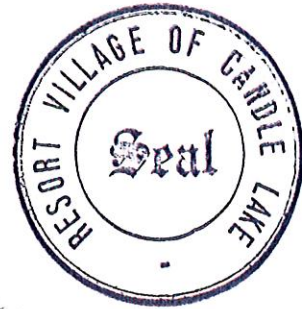
